## 4. Participation

A member district may send a maximum of 24 fencers (12 Boys and 12 Girls) having 4 Boys/4 Girls per weapon, with a maximum of one entry in every team event and all the 4 fencers of the team have to participate in an individual event.

NOTE: At least one woman team official shall necessarily accompany the Female Fencers from each affiliated member unit.

a) Enrolment : **Last date for submission of entries – 5 pm, 20<sup>th</sup> December, 2025**  
Entries beyond the last date & time will not be admitted.

b) Registration Form : i) Duly filled in Registration Form with an attested copy of Aadhaar Card/Passport  
ii) Duly Filled in Entry Form with a self attested copy of Aadhaar Card and 2 (TWO) Passport Size Photographs of the fencer.

c) Entry Fee - INR 1,500/- (Rupees one thousand five hundred only) per fencer per event participation.

d) Competition Management – In accordance with the Rules/Guidelines issued from time to time in this sports discipline by FAI.

e) Fencing Equipments – All the fencers should be equipped fully with fencing uniform, mask and gear, failing which they will not be permitted to take part in the championship.

f) FAI Guidelines, as circulated under this Association's letter in July, 2023, are reproduced below for strict adherence by all concerned.

- As per the norms of the FAI, it is mandatory for all fencers, coaches, and referees/technical officials to register and obtain a FAIID. The State Associations shall ensure that all fencers, coaches, and officials participating in the State Fencing Championships are registered with the FAI.
- Fencers who only compete in the District or State Fencing Championships may register in the category titled Fencer A+ with a fee of Rs.650/- only.
- Coaches working at the grassroots level in Districts with minimum qualification may register as Grade D/ Grade E coaches with a fee of Rs.1000/- only.
- TOs only officiating in the District or State Fencing Championships with minimum qualification may register as Grade C/ Grade D TOs with a fee of Rs.1000/- only.

### Note:

i) Only Boarding (Break-fast, Lunch & Dinner ) Will be provided for Players , coaches and Technical officials on the days of Championship .

ii) The parents accompanying their wards participating in the championship shall be advised to stay away from the arena of the championship events.
