Sub: State Sub-Junior (U-14) Fencing Championship - 2025-26 - to be held at Sri Krishna Engineering College, Panapakkam, Near Padappai, Via Tambaram, Chennai-601301 on 11<sup>th</sup> & 12<sup>th</sup> October, 2025.

Tamil Nadu Fencing Association (Adhoc Committee) are pleased to inform that the State Sub-Junior (U-14) Fencing Championships for Boys and Girls has been scheduled to be held in Individual/Team events in FOIL, EPEE and SABRE weapon categories, under the aegis of Fencing Association of India, at Sri Krishna Engineering College, Panapakkam, Near Padappai, Via Tambaram, Chennai-601301 on 11<sup>th</sup> (Saturday) & 12<sup>th</sup> (Sunday), October, 2025.

The Terms and Conditions are as follows for adherence and compliance by everyone.

Age Criteria : Boys and Girls less than 14 years of age as on 1<sup>st</sup> January, 2026, i.e., the fencers born on or after 01-01-2012 are only eligible to participate in the said championship.

Member Units are, therefore, requested to confirm immediately the number of participants and submit the Entry Form in the prescribed format.

The fencers, their parents/guardians shall NOTE that the age eligibility, i.e. cutoff date of birth, is as determined by the Fencing Association of India as guided by **Fédération Internationale d'Escrime** and the Tamil Nadu Fencing Association (Adhoc Committee) shall have no decision making authority in this respect, in case there is a change in the cutoff

date of birth, for determining the eligibility criterion. The participation of fencers shall be with the above understanding on age eligibility criterion.

1. Date of events - 11<sup>th</sup> October, 2025 (Saturday) – Girls  
12<sup>th</sup> October, 2025 (Sunday) - Boys
2. Venue - Sri Krishna Engineering College, Panapakkam,  
Near Padappai, Via Tambaram, Chennai-601301.
3. BUS Route & Stop - From Tambaram Railway Station (on the western side) – GST  
Road, Bus Nos. 79A, 579, 583, proceeding towards Oragadam,  
Sriperumbudur, Walajabad, Kanchipuram, etc.

Entry - **Last date for submission of entries – 9<sup>th</sup> October, 2025  
For Boys & Girls**

Entries beyond the last date will not be admitted.

4. Entry Form : i) Duly filled in Registration Form with an attested copy of  
Aadhaar Card/Passport  
ii) Duly Filled in Entry Form with a self-attested copy of  
Aadhaar Card and 2 Passport Size Photographs of the  
fencer.
5. Entry Fee - Rs. 1,500/- (Rupees One Thousand and Five Hundred only)  
per fencer per event participation.
6. Competition Management – In accordance with the Rules/Guidelines issued from  
time to time in this sports discipline by FAI.
7. Fencing Equipments - All the Fencers should be equipped fully with Fencing  
Uniform, Mask and Gear, failing which they will not be permitted to take part in the  
championship.
8. FAI Guidelines as circulated under this Association's letter in July, 2023, are reproduced  
below for strict adherence by all concerned.
  - As per the norms of the FAI, it is mandatory for all fencers, coaches and referees/  
technical officials to register and obtain a FAI ID. The State Association should  
ensure that all fencers, coaches and officials participating in the State Fencing  
Championships are registered with the FAI.
  - Fencers who compete in the District or State Fencing Championship may register  
in the category titled Fencer A+ with the fee of INR 650/- only.
  - Coaches working at the grassroots level in District with minimum qualification  
may register as Grade D/Grade E coaches with the fee of INR 1,000/- only.

- TOs only officiating in the District or State Fencing Championship with minimum qualification may register as Grade C/Grade D TOs with a fee of INR 1,000/- only.
- **FAI have advised in their recent Letter No.FAI/2025-26/08/709 dated 25-09-2025 that all the participating fencers at all the National Championships to possess valid Passport, a mandatory document, for new as well as renewal of registration to generate FAI ID and also to enable them to take part in International events.**

A member district may send a maximum of 24 fencers (12 Boys and 12 Girls) having 4 Boys/4 Girls per weapon.

At least one woman team official shall necessarily accompany the Female Fencers from each affiliated member unit.

**Note:**

- Participating Fencers, Coaches and Managers may please note that they shall make their own arrangements for their stay.
- Food (Break-fast, lunch and dinner) will be provided for Players, Technical Officials and Officially nominated District Coaches & Managers accompanying the players during the championship.

Private Coaches & Managers of the players and the Parents accompanying their wards participating in the championship shall be advised to stay away from the arena of the championship events. Any breach by any individual will be dealt with in accordance with the law by duly invoking the Law Enforcing agency in the jurisdiction.

**This State Sub-Junior Championship is a selection of players for the ensuing Sub-Junior National Fencing Championship scheduled to be held from 3<sup>rd</sup> to 8<sup>th</sup> November, 2025, at Imphal, Manipur.**
